RESOLUTION NUMBER R- 282059

ADOPTED ON JUN 01 1993

WHEREAS, the economic recession which has affected the City of San Diego has resulted in loss of jobs and economic hardship for San Diego's families; and

WHEREAS, young people in San Diego seeking jobs in the summer of 1993 are likely to experience limited employment opportunities because of the City's economic condition; and

WHEREAS, summer jobs are important to young people in developing their career goals and reinforcing their aspirations to become contributing members of our community; and

WHEREAS, the Summer Employment and Jobs Training Program which was proposed to receive \$1 billion supplemental funding in the summer of 1993 would have provided the youth of San Diego with up to 12,000 additional jobs this summer; and

WHEREAS, the Senate failed to approve this increased funding; and


WHEREAS, the Department of Legislative Services (DLS) Report No. 93-15, dated May 11, 1993, was heard and approved at the City Council Committee on Rules, Legislation and Intergovernmental Relations on May 24, 1993; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor and Council of the City of San Diego expresses its enthusiastic support for supplement funding for the Summer Youth Employment and Jobs Training Program;

BE IT FURTHER RESOLVED, that the San Diego City Council calls upon the Mayor to prepare and send letters to the San Diego Congressional Delegation and appropriate Congressional Committee members and Administration representatives calling for quick legislative action to ensure that San Diego's youth will have additional jobs available to them in the summer of 1993.
