RESOLUTION NUMBER R- 282060

ADOPTED ON JUN 01 1993

WHEREAS, AB 1313 (W. Brown) proposes sales tax exemptions for manufacturers to enhance California's competitive environment for attracting new and expanding manufacturing facilities; and

WHEREAS, the estimated loss of revenue to the City of San Diego could exceed \$11 million; and

WHEREAS, this loss of revenue to San Diego could further limit the City's ability to provide the basic City services which business requires to locate and expand in our community; and

WHEREAS, the Department of Legislative Services (DLS) Report No. 93-18, dated May 17, 1993, was heard and approved at the City Council Committee on Rules, Legislation and Intergovernmental Relations on May 24, 1993; NOW, THEREFORE,


BE IT RESOLVED, that the Mayor and the Council of the City of San Diego actively opposes AB 1313 (W. Brown) and urges the State of California to take responsible action to resolve its budget and business competitiveness problems without doing further damage to cities which must provide the basic services on which business must rely.

BE IT FURTHER RESOLVED, that the City Council hereby directs the Department of Legislative Services to make the City's

opposition known to the author and to the appropriate legislative committees.


