RESOLUTION NUMBER R-2 8 2 0 6 3

ADOPTED ON JUN 01 1993

WHEREAS, California Government Code section 4420 prohibits public agencies from directing contractors to acquire insurance from a specific company and/or acquiring insurance coverage which the contractor should acquire as a part of his/her contract; and

WHEREAS, this prohibition prevents public agencies in California from utilizing a comprehensive insurance package approach to insuring major construction projects called "Project Wrap-Up Insurance"; and

WHEREAS, the Legislature has provided exemption from this prohibition for large public projects such as the B.A.R.T. transportation project in San Francisco, Metrolink in Los Angeles and the light rail transit project in Sacramento; and

WHEREAS, the City of San Diego desires to join the City of Fresno in seeking an exemption from Government Code section 4420 for large wastewater projects in their regions; and

WHEREAS, the Department of Legislative Services (DLS) Report No. 93-8, dated April 5, 1993, was heard and approved at the City Council Committee on Rules, Legislation and Intergovernmental Relations on May 24, 1993; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that this City Council approves adding to the City of San Diego's Legislative Sponsorship Program legislation to exempt the San Diego Clean Water Program from the prohibition on project wrap-up insurance, all as set forth in DLS Report #93-8, dated April 5,

1993.

BE IT FURTHER RESOLVED, that the City Council hereby directs the Department of Legislative Services and the City's Sacramento lobbyist to work cooperatively with the City of Fresno to seek such legislation.
