BE IT RESOLVED, by the Council of The City of San Diego that the low bid of JONES CHEMICALS, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LIQUID CHLORINE IN ONE-TON CYLINDERS AND LIQUID CHLORINE IN 150-LB. CYLINDERS as may be required for a period of one (1) year beginning July 1, 1993 through June 30, 1994, at a cost of \$314.00 per ton and \$33.00 per CWT respectively, for a total estimated annual cost of \$311,058.00; terms net 30 days, plus refundable cylinder deposits of \$1,000.00 each for one ton cylinders and \$150.00 each for 150 lb. cylinders; with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed 20% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, That in the event the contract vendor is unable to deliver at any time during the contract period, the Purchasing Agent is hereby authorized to obtain chlorine from the next low bidder and from subsequent bidders, if necessary, or to obtain chlorine on the open market until the contract can be rebid.
