ADOPTED ON JUN 07 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. SAFETY SUPPLY AMERICA, 2. LIFECOM-SAFETY SERVICE AND SUPPLY CO., and 3. R. J. SAFETY SUPPLY CO., INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing RESPIRATORS, CARTRIDGES, PARTS AND SERVICE as may be required for a period of one (1) year beginning May 1, 1993 through April 30, 1994 per prices on file in the Purchasing Department, as follows:

1. SAFETY SUPPLY AMERICA for Section I - Manufacturer - Scott; Section IV - Manufacturer - Willson, for a total estimated cost of \$47,878.00; terms net 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods at prices not to exceed 5% of prices in effect at the end of prior contract period.

2. LIFECOM-SAFETY SERVICE AND SUPPLY CO. for Section II - Manufacturer - Survivair, for a total estimated cost of \$21,236.00; terms net 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods at prices not to exceed 15% of prices in effect at the end of prior contract periods.

3. R. J. SAFETY SUPPLY CO., INC. for Section III - Manufacturer - M.S.A. (Hycar and Silicone); Section V - Manufacturer - American Optical; Section VI - Manufacturer - North, for a total estimated cost of \$24,125.00; terms 1% 20 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods at prices not to exceed 5% of prices in effect at the end of prior contract periods.
