
ADOPTED ON JUN 07 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of FINNIGAN CORPORATION, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE EACH CHROMATOGRAPH/MASS SPECTROMETER SYSTEM at a cost of \$273,440.00; terms net 20 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$294,631.60 from Fund No. 41500, Department No. 700, Organization No. 425, Object Account No. 6010, and Job Order No. 16208, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
