That pursuant to Council Policy No. 800-2, payment is hereby authorized to all property owners in the Mission Gorge Road (Zion Avenue to Greenbriar Avenue) Underground Utility District as reimbursement for electrical service underground conversion work done on private property whenever the required length of trenching exceeds 1 foot, from Case 8209 funds held by the City Treasurer for this purpose.
- 4. That the City Auditor and Comptroller is hereby authorized to return to San Diego Gas & Electric Company any undisbursed funds upon written notice from San Diego Gas &

Electric Company to the City that all electric service conversions within a particular district have been completed.
