BE IT RESOLVED, by the Council of The City of San Diego, that a sewer easement is hereby permanently set aside and established in that portion of the Famosa Slough channel described in Attachments 1 and 2 hereto.

BE IT FURTHER RESOLVED, that the following amendment shall be added to Attachment 1:

As the easement area is in a sensitive wildlife area and is a visual attraction, no cleaning or storing of equipment within the easement area shall be allowed and that improvements or repairs to be made in the easement area shall be subject to advance review and recommendation from San Diego Gas & Electric Company and the City's Park and Recreation Department; that maintenance and operation activities shall not cause increased erosion or water turbidity, introduce contaminants or litter to the adjacent water, or introduce any contaminants to the soil; all activity which would be disruptive to fish or native bird reproduction and rearing shall be scheduled to avoid sensitive times of the year; and, the introduction of plants or animals not indigenous to the local native habitat shall be avoided within or around the easement area.


