

RESOLUTION NUMBER R- 282108

ADOPTED ON JUN 07 1993

WHEREAS, The City Council and the Fourth Council District Office have recognized the poor economic conditions in the Fourth District and have focused on assisting the residents of this District through redevelopment efforts; and

WHEREAS, the San Diego Unified School District owns property adjacent to the Martin Luther King Freeway and abutting the Gompers Secondary School; and

WHEREAS, this parcel, along with six (6) other separately owned parcels adjacent to the School District's parcel, has been identified as an attractive site for redevelopment efforts; and

WHEREAS, the combined acreage (approximately 13-acres) would provide an ideal location for a store which will increase employment opportunities for Fourth District residents and provide much needed retail services; and

WHEREAS, although the School District has already approved another use for the property, it has indicated a willingness to consider negotiations for other uses of the property if requested by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that it respectfully requests the San Diego Unified School
District consider using the property for redevelopment efforts.
