ADOPTED ON MAY 18 1993

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate where appropriate the City's land use regulatory procedures; and

WHEREAS, the Planning Department has reviewed San Diego Municipal Code section 103.0302.3, relating to the La Jolla Shores Planned District, and has suggested an amendment to the code section to streamline the regulatory process as shown in Exhibit A, attached hereto and incorporated by reference; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That staff from the Planning Department work with the City Attorney's Office so that the proposed amendment to Municipal Code section 103.0302.3 be reviewed as to legality and put in appropriate form.

2. That following the review for form and legality, staff are directed to set the matter for a public hearing as set out in Municipal Code section 103.0101 et seq.

3. That the Planning Commission be directed to hold a public hearing on the matter of the proposed amendments to Municipal Code section 103.0302.3 and immediately transmit its

recommendations concerning those amendments to the City Council following the hearing.
