

RESOLUTION NUMBER R- 282117

ADOPTED ON MAY 18 1993

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate where appropriate, the City's land use regulatory procedures; and

WHEREAS, the Planning Department has reviewed San Diego Municipal Code section 103.0900 et seq. having to do with the Barrio Logan Planned District, and has suggested several amendments to the code section to streamline the regulatory process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That staff from the Planning Department work with the City Attorney's Office so that the proposed amendments to Municipal Code section 103.0900 et seq. be reviewed as to legality and put in appropriate form.

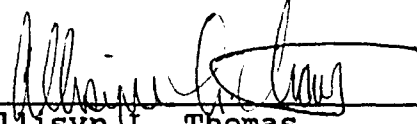
2. That the proposed amendments to Municipal Code section 103.0900 et seq. then be forwarded to the Planning Commission.

3. That the Planning Commission be directed to hold a public hearing on the matter of the proposed amendments to Municipal Code section 103.0900 et seq. and immediately transmit
