RESOLUTION NUMBER R- 282126
ADOPTED ON MAY 18 1993

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate, where appropriate, the City's land use and environmental regulatory procedures; and

WHEREAS, the Building Inspection Department and Planning Department have reviewed San Diego Municipal Code Sections 101.0500 and 101.0514, having to do with the storage of moved buildings, and have suggested that amendments be made to other provisions of the Municipal Code to streamline the regulatory process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the staff of the Building Inspection Department and Planning Department be directed to work with the City Attorney to prepare the necessary ordinances that would allow for the temporary storage of relocated buildings in certain industrial and commercial zones if a ministerial permit is obtained.

2. That the proposed amendments to the Municipal Code be forwarded to the Planning Commission.

3. That the Planning Commission be directed to hold a public hearing on the matter of the proposed amendments to the

Municipal Code and immediately transmit its recommendations concerning those amendments to the City Council following the hearing.
