WHEREAS, the San Diego Black Nurses Association ("Association") was founded in San Diego in April 1976 by a group of six nurses who felt the need to address general health care issues of African-Americans; and

WHEREAS, the Association now has sixty-five nurses acting as advocates in the field of health care by encouraging and assisting Black nurses in publishing and writing articles relevant to health care issues; and

WHEREAS, the Association has increased the level of awareness in the entire San Diego Community, in regard to the two health hazards prevalent in the African-American Community: Hypertension and Sickle Cell Anemia; and

WHEREAS, the Association is comprised of concerned and dedicated people who strive to unify Black nurses in San Diego; and

WHEREAS, the Association has established a cordial working relationship with other health care groups and agencies; and

WHEREAS, the Association assists in enhancing educational opportunities by providing scholarships to assist aspiring nursing students to pursue their goals in the field of medicine; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego,

hereby commends the San Diego Black Nurses Association for their sterling leadership and dedication promoting better access to health care for African-Americans.

BE IT FURTHER RESOLVED, that June 13, 1993 be and is hereby proclaimed to be "ANNUAL FOUNDERS DAY" in San Diego.
