BE IT RESOLVED, by the Council of The City of San Diego that the bid of MEC ANALYTICAL SYSTEMS, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SORTING OF OCEAN BENTHIC SAMPLES as may be required for a period of one (1) year beginning June 1, 1993 through May 31, 1994 at a cost of \$236.76 per sample for samples from Pt. Loma and \$140.73 per sample for samples from 21 outlying stations, for a total estimated cost of \$108,876.24; terms net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed 5% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder or to obtain this service on the open market until it can be re-bid.
