BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. HANDAR, INC. AND 2. PROCESS AUTOMATION PRODUCTS, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of an ALERT WEATHER/WATER LEVEL MONITORING SYSTEM as follows:

- 1. HANDAR, INC. for Items 1 thorough 25 and 27 through 46, per prices on file in the Purchasing Department, for a total cost of \$187, 105.25; terms net 30 days, plus sales tax.
- 2. PROCESS AUTOMATION PRODUCTS for Item 26, per prices on file in the Purchasing Department, for a total cost of \$37,305.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$241,802.05 from Fund No. 41500, Department No. 700, Organization No. 313, Object Account No. 6010, and Job Order No. 17368, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
