BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNALS AND STREET LIGHTING SYSTEMS AT EUCLID AVENUE AND HOME AVENUE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$10,000.00 from CIP 68-010.0, CONSTRUCT TOP 10-15 PRIORITIZED TRAFFIC SIGNALS, Fund 30300, to CIP 62-292.0; and authorizing the expenditure of

\$110,000.00 from CIP 62-292.0, TRAFFIC SIGNALS - DIF FUNDED,
(\$100,000.00 from Fund 79504 and \$10,000.00 from Fund 30300), for
the purpose of executing this contract and related costs, and
authorizing the Auditor and Comptroller, upon advice from the
administering department, to retain excess monies, if any, in CIP
68-010.0.
