BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of GOODWILL INDUSTRIES OF SAN DIEGO COUNTY, INC., a California corporation, executed in favor of The City of San Diego, bearing date of February 18, 1993, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 282141-1, granting to said City an easement for public street purposes in that portion of Pueblo Lot 316, Parcel 11 as per Record of Survey No. 1344, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SPORTS ARENA BOULEVARD.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a Joint Use Agreement with SAN DIEGO GAS & ELECTRIC COMPANY, a California corporation, in connection with the above street dedication, under the terms and conditions set forth in that Joint Use Agreement on file in the office of the City Clerk as Document No. RR- 282141-2.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder,

the easement deed at no fee for the benefit of the City, with no documentary tax due.
