BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to apply for, accept and expend a grant from the United States Office of Justice Programs, Bureau of Justice Assistance, titled "Comprehensive Gang Initiative," the purpose of which is to develop and implement a neighborhood oriented approach to drug/gang elimination as described in the grant application proposal, a copy of which is on file in the Office of the City Clerk as Document NO. RR- 282143

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute said grant agreement, and the authority of the City Manager shall include all aspects of program operation and expenditures, under the terms and conditions of the approved grant program proposal, including any amendments or extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said grant.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED, that personnel positions funded by this grant award are not subject to local hiring freezes.
