
RESOLUTION NUMBER R- 282147

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from CIP 37-056.0 West Miramar Phase II, Waste Management CIP Fund 41201, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
