BE IT FURTHER RESOLVED, the Council hereby provides comments, addition, and/or deletions to the areas proposed to be explored for consolidation.


BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to forward the recommendations to the County Board of Supervisors.
