WHEREAS, the Board requires special legal expertise in matters concerning real estate transactions involving multi-family residential investments with co-investors; and

WHEREAS, the City Attorney's office serves as legal counsel to the Board but does not have the required specialized legal expertise on staff concerning real estate transactions involving multi-family residential investments with co-investors; and

WHEREAS, it is necessary and desirable to employ outside counsel with real estate law expertise to provide such specialized advice and support as may be required by the City Attorney, with payment therefor to come from the retirement system; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney be and he is hereby authorized and empowered to execute an agreement with the firm of HILLYER & IRWIN for legal consultant services in the area of real estate

transactions involving multi-family residential investments with co-investors on a requirement basis, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- $\frac{282158}{}$.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000 from fund 60011/088, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement.
