

RESOLUTION NUMBER R- 282184

ADOPTED ON JUN 28 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. IMPERIAL IRRIGATION SUPPLY, INC., 2. HYDRO-SCAPE PRODUCTS, INC. and 3. MAJOR IRRIGATION SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS, IRRIGATION VALVES AND REPAIR PARTS as may be required for a period of one (1) year beginning June 1, 1993 through May 31, 1994 per prices on file in the Purchasing Department as follows:

1. IMPERIAL IRRIGATION SUPPLY, INC. for Group I - Rainbird Sprinklers and Repair Parts, and Group II - Buckner Sprinklers and Repair Parts for an estimated cost of \$220,000.00; terms 2% 30 days, plus sales tax.
2. HYDRO-SCAPE PRODUCTS, INC. for Group III - Hydro-Rain Irrigation Valves and Repair Parts, and Group IV - Weathermatic Valves and Repair Parts for an estimated cost of \$21,000.00; terms 2% 10th prox., plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with prices not to exceed 5% of prices in effect at the end of each prior year.
3. MAJOR IRRIGATION SUPPLY for Group V - Hunter Heads and Repair Parts for an estimated cost of \$60,000.00; terms 1% 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods at no percentage price increase.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
