BE IT RESOLVED, by the Council of The City of San Diego that the sole bid of INFILCO DEGREMONT INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for EIGHT (8) EACH ROOF SLUDGE HEATING AND MIXING GUNS at a cost of \$14,396.875 each and ONE (1) EACH ROOF MOUNTED SLUDGE MIXING GUN at a cost of \$6,300.00 for a total cost of \$121,475.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$130,889.31 from Department No. 700, Organization No. 407, Object Account No. 3265, and Job Order No. 2511, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
