BE IT RESOLVED, by the Council of The City of San Diego that the low bid of NORTHWESTERN CARBON, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing REMOVAL AND DISPOSAL OF OLD CARBON AND INSTALLATION OF NEW CARBON IN ODOR CONTROL TOWERS at Pt. Loma Wastewater Treatment Plant at a price not to exceed \$341,484.00 including sales tax; terms 1% 10 days.

BE IT FURTHER RESOLVED, that in the event the contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$341,484.00 from Department No. 700, Organization No. 400, Object Account No. 4222, and Job Order No. 2501, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
