RESOLUTION NUMBER R-282192

ADOPTED ON JUN 28 1993

WHEREAS, on February 9, 1993, the Council of The City of San Diego approved the declaration by the City Manager of the existence of a continuing local emergency; and

WHEREAS, the City Manager of The City of San Diego found that conditions of extreme peril to the safety of persons and property had arisen within the City, caused by heavy rains, mud slides and severe urban flooding; and those conditions continued to exist; and

WHEREAS, on March 15, 1993, the Council of The City of San Diego adopted Resolution No. R-281578 declaring the existence of a continuing local emergency; and

WHEREAS, during the existence of this local emergency, the City Manager was required to purchase and install a Bailey bridge on Hollister Street in The City of San Diego over the Tijuana River at a cost of \$154,000.00; and

WHEREAS, section 22.0504 of the San Diego Municipal Code provides that in the case of a bonafide emergency affecting public health or safety, the City Manager shall report the purchase to the City Council who shall then by Resolution so note and ratify the procurement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the purchase by the City Manager of a Bailey bridge which was installed on Hollister Street in The City of San Diego over

the Tijuana River, at a cost of \$154,000.00 is hereby noted and the procurement is ratified.
