BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for IMPROVEMENT OF SAN YSIDRO BOULEVARD - SMYTHE AVENUE TO BORDER VILLAGE ROAD (PHASE 1A) PARKING LOT WEST OF WILLOW ROAD in accordance with the specifications.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$60,000.00 from CIP 58-007.0, OVERHEAD AND OTHER CITY COSTS FOR FEDERAL GRANT PROJECTS (Capital Outlay Fund 30245), to CIP 52-166.1, IMPROVEMENT OF SAN YSIDRO BLVD. - SMYTHE AVENUE TO BORDER VILLAGE ROAD; and authorizing the expenditure, not to exceed \$60,000.00, from CIP 52-166.1, for the purpose of executing this contract and related costs.
