RESOLUTION NUMBER R-282200

APPROVING PARCEL MAP W.O. NO. 910801.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Donald G. Baker, Licensed Land Surveyor, entitled "Parcel Map W.O. No. 910801 being a division of Lot 1 of Webb's Acres, according to Map thereof No. 5552, filed in the office of the County Recorder of San Diego County, April 2, 1965, and the west 121.08 feet of Lot 19 of Aloha Tract, according to Map thereof No. 611, filed in the office of the County Recorder of San Diego County, August 8, 1889, together with that portion of east half of that certain unnamed street lying westerly of and adjoining said Lot 19, as vacated and closed to public use, and that portion of the south one-half of that certain unnamed street, lying between Lots 11 and 19 of said Aloha Tract vacated and closed to public use lying north of and adjacent to the above described portion of said Lot 19, and lying north and adjoining the east one-half of the vacated unnamed street adjacent and westerly of said Lot 19, all being in the City of San Diego, County of San Diego, State of California, subject to a portion of Elder Avenue (formerly Elder Street) as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys;

that said parcel map is in substantial conformance with the approved tentative map; that said parcel map and the division of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby presently rejects as a dedication those portions of Parcel 4 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code, but reserves the right to dedicate all or any portion of such reserved area to public street purposes at any time in the future.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The city of San Diego, a municipal corporation, the easements with the right of way for earth embankment slopes together with the right to construct and maintain such slopes and embankments and facilities incidental thereto, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has approved said parcel map and that said Council has for the present rejected as a dedication those portions of Parcel 4, marked "Reserved for Future Street"; that those easements with the right-of-way for earth embankment slopes, as granted and shown on this parcel map, are accepted on behalf of The City of San Diego, a municipal corporation as above stated.
