NO. 920490 being a lot consolidation of all of fractional Block 96 of subdivision of Pueblo Lot 1157, commonly known as Mannasse and Shiller's Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 209, filed in the office of the County Recorder of San Diego County, July 11, 1870, and all of fractional Block 96 of San Diego Land and Town Company's Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 379, filed in the office of the County Recorder of San Diego County, October 30, 1886; together with a portion of Dewey Street and the unnamed alley within said Block 96, as vacated and closed to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the lot consolidation shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: A portion of Evans Street, and said portion of a public street is hereby declared to be a portion of a public street and dedicated to the public use, as
