RESOLUTION NUMBER R- 282202

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of grant deeds of CONNECTICUT MUTUAL LIFE INSURANCE COMPANY, executed in favor of The City of San Diego, bearing dates of July 30, 1992, and July 31, 1992, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-282202-1 and RR-282202-2, granting to said City easements for public street purposes and electrical facilities in portions of Lot 2 of North Clairemont Plaza, Map No. 3484, and in Parcel A of Parcel Map 1228, as more particularly described in the deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named CLAIREMONT DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, the street easement deed at no fee for the benefit of the City, with no documentary tax due.
