BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to implement a Community Based Ultra-Low Flush Toilet Pilot Replacement Program.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to execute a Memorandum of Understanding with the San Diego County Water Authority ("CWA") to implement and administer the Community Based Ultra-Low Flush Toilet Pilot Replacement Program on file in the office of the City Clerk as Document No. RR- 282228 .

BE IT FURTHER RESOLVED, that the City Council authorizes the expenditure not to exceed one hundred thirty-five thousand dollars (\$135,000.00) from the Water Utilities Department Operating Fund (41500), Water Conservation Program (70622), for the sole and exclusive purpose of implementing a Community Based Ultra-Low Flush Toilet Pilot Replacement Program.
