WHEREAS, the Council of The City of San Diego (the "City")
has previously given its general approval to financing plans for
the Gateway Center West Project Area and the Central Imperial
Project Area of the Redevelopment Agency of The City of San Diego
(the "Agency"); and

WHEREAS, the City has adopted the Fiscal Year 1992-93

Program Budget for the Southeast Economic Development Corporation
("SEDC"); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That it hereby approves augmenting the Gateway Center West budget, fund 98350, by forty thousand dollars (\$40,000) from Tax Increment Fund 983513.
- 2. That it hereby accepts as a loan repayment from the Mt. Hope Redevelopment Project, forty-five thousand dollars (\$45,000) in sales tax proceeds.
- 3. That it hereby transfers to the Redevelopment Agency, forty-five thousand dollars (\$45,000) as an interest-bearing loan, to be used in the FY 92-93 Central Imperial Project budget for implementation costs.
- 4. That the Auditor and Controller is hereby directed to record the above-indicated loan of forty-five thousand dollars

(\$45,000), as an interest bearing loan to the Redevelopment Agency, to be repaid as soon as practicable from tax increment or other appropriate revenues.
