
BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Government Code section 54954.6, the City Clerk be and he is hereby directed to provide at least forty-five (45) days public notice of a public hearing on a proposed ordinance which would amend the San Diego Municipal Code to provide for increased new license taxes for the collection, transport and disposal of refuse within the City.

BE IT FURTHER RESOLVED, that among other things, notice shall provide that the contemplated increased and new license taxes shall constitute a sum equal to \$10 of each ton of refuse deposited at City solid waste landfills.

BE IT FURTHER RESOLVED, that the estimated amount of revenue to be raised annually is approximately \$8 million; and that the hearing shall take place at the CAB, 202 "C" Street, 12th Floor, on August 16, 1993.

BE IT FURTHER RESOLVED, that the notice shall contain all other information needed to comply with Government Code section 54954.6.
