BE IT RESOLVED, by the Council of The City of San Diego that the low bid of CUSTOM PACIFIC SIGN & INSTALLATION is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of REFLECTORIZED HIGHWAY SIGNS AND ALUMINUM BLANKS as may be required for a period of one (1) year beginning June 1, 1993 through May 31, 1994 per prices on file in the Purchasing Department, for a total estimated annual cost of \$335,971.00; terms 1% 21 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 10%.

BE IT FURTHER RESOLVED, that in the event the contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder, and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.


