BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF BONITA PIPELINE PHASE 1A.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$3,509,075.00 from Water Revenue Fund 41500, CIP 73-195.0, BONITA PIPELINE, is hereby authorized solely and exclusively for providing funds for said project and related costs.


