
WHEREAS, pursuant to San Diego Municipal Code section 67.58 the rates to be charged and collected for Fire Hydrant service within The City of San Diego shall be established from time to time by a resolution of the City Council; and

WHEREAS, prior to considering any change in the water service charge by resolution, a notice of the proposed change shall be posted by the City Clerk at least ten (10) days prior to consideration of such a resolution by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to change the Fire Hydrant service rate charged for hydrants located on City property from six dollars (\$6.00) per hydrant per annum to zero dollars (\$0.00) per hydrant per annum.
