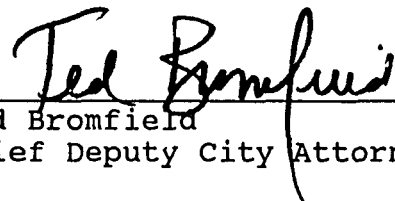
ADOPTED ON JUL 06 1993

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000 from the Sewer Revenue Fund 41506, CIP No. 44-001.0, is hereby authorized, solely and exclusively to fund the above changes orders.

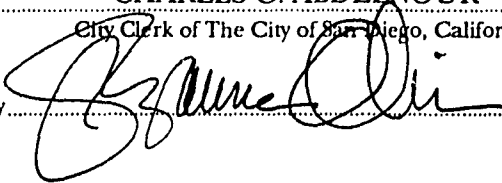
