ADOPTED ON JUL 06 1993

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council hereby authorizes the City Manager to submit a claim to the San Diego Association of Governments ("SANDAG") and accept Local Transportation and/or TransNet funds for a grant to:

a. Study the impacts of all options that would reduce congestion and improve safety on the Ocean Front Walk (Mission Beach) boardwalk including, but not limited to, the alternatives in Attachment 2 of Manager's Report No. 93-174 and specifically:

- Restricting wheeled activity from the boardwalk (except usage by persons with disabilities);
- Widening the boardwalk to the west;
- Defining potential public safety hazards (for homeowners as well as boardwalk users) if the boardwalk is widened;
- Adding a line down the center of the boardwalk to separate pedestrians and wheeled traffic;
- Installing speed bumps;
- Seeking solutions from other municipalities; and

b. Develop alternative engineering conceptual plans, associated cost estimate, and potential sources of funds for the recommended solutions.

2. That once the study is completed, the City Manager will return all findings to City Council for review.

3. Expedite this issue of authorizing grant application/  
acceptance to City Council before SANDAG's meeting of June 16,  
1993.


