WHEREAS, PWC, San Diego maintains over 7,700 housing units for military service members and their families residing in the San Diego area; and

WHEREAS, PWC, San Diego executes over 13,000 government contracts per year to procure products and services from local San Diego and Southern California businesses; and

WHEREAS, PWC, San Diego employs an experienced and dedicated work force of over 2,400 people, generating an annual payroll in excess of \$80 million; and

WHEREAS, PWC, San Diego is an Equal Opportunity Employer which prides itself on meeting or exceeding its minority hiring goals; and

WHEREAS, PWC, San Diego contributes over \$350 million worth of business per year into the San Diego and Southern California economy; and

WHEREAS, PWC, San Diego contributes to the local community through partnership and outreach programs with local schools, businesses and industry; and

WHEREAS, PWC, San Diego will celebrate its thirtieth anniversary of operations during the week of July 18, 1993; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, in recognition of Navy Public Works Center, San Diego's thirty years of service to the Navy and to this city,

hereby declares the week of July 18 through 24, 1993 to be "NAVY


