
ADOPTED ON JUL 12 1993

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$198,284.00 from Sewer Revenue Fund No. 41506, CIP No. 46-134.0, Point Loma Sedimentation Basins 11 and 12 and South Effluent Outfall Connection Project, be and is hereby authorized, solely and exclusively to provide funds for this amendment.


