

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$45,000 from CIP 37-250 Landfill Closure and Environmental Projects, Fund 41210 Waste Management - CIP, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
