

RESOLUTION NUMBER R-282348

ADOPTED ON JULY 12, 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby confirms and amends the June 2, 1993 Public Services and Safety Committee actions to:

1. Restore senior nutrition to its 1993 funding level.
2. Fund the Regional Task Force on the Homeless at \$30,000 and add a new program called Citizen Patrol Project in Hillcrest for a cost of \$25,000 to be funded by asset seizure funds.
3. Reduce all programs on a prorated basis. However, the discussion on funding of the Access program shall be deferred until July 26, 1993.
4. Direct the City Manager to not allow the Neil Good Day Center for the Homeless to serve more homeless than contracted for.
5. Direct the City Manager to proceed with the consolidation of the City/County senior nutrition program.
6. Direct the City Manager to return to the Council with a work program describing the impact of implementing an application process for social services.
7. Delete the funding for the Community Services Center for the Disabled and direct that it be funded by the Housing Commission.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to return with appropriate social service agreements taking the above directions into account.


