BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she was hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF DESERT VIEW DRIVE SHEAR PIN INSTALLATION in accordance with the specifications.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer an additional \$100,000.00 from Fund No. 30300, "TransNet Proposition 'A'" to CIP No. 52-566.0; and authorizing the additional expenditure not to exceed \$100,000.00 from CIP No. 52-566.0, TransNet Fund 30300, for construction and related costs, and authorizing the Auditor and Comptroller to transfer excess funds, if any, to the appropriate reserves.


