APPROVING MAP OF WESTVIEW UNIT NO. 6.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by William Gregory Clarke, Licensed Land Surveyor, entitled "WESTVIEW UNIT NO. 6, being a subdivision of portions of the Northeast Quarter, and the north half of the Southeast Quarter of Section 30, according to Record of Survey 6671, filed in the office of the County Recorder of San Diego County April 11, 1966, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the Official Plat thereof," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon, or across portions of Lots 47, 48, 49, and 50, as

granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; that the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
