

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000 from CIP 33-076.0, Fire Station No. 43 -

Otay Mesa from Capital Outlay Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
