SAN DIEGO TO ACCEPT CITY MANAGER'S REPORT
NO. 93-192 REVISED, ECONOMIC DEVELOPMENT
STRATEGIC PLAN UPDATE, INCLUDING THE PROPOSED
ECONOMIC DEVELOPMENT STRATEGIC PLAN FY 1994.

WHEREAS, the Council of The City of San Diego, on June 15, 1992, adopted the Economic Development Program Report, including the Strategic Plan; and

WHEREAS, the City Manager was directed to report on the status of those issues to be implemented in the Strategic Plan; and

WHEREAS, it is in the public interest that the recommendations and strategies outlined in City Manager's Report No. 93-192 Revised be implemented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That it hereby accepts City Manager's recommendations 1 through 4 as set out in City Manager's Report No. 93-192 (Revised) on pages 1 and 2.

2. That City staff develop ways to ensure they will better communicate and coordinate with small businesses regarding public improvement projects that may impact those businesses and also provide information regarding the availability of financial assistance to small businesses.

3. That the City Manager be and is hereby authorized and empowered to request from the Unified Port District, a loan of
