RESOLUTION NUMBER R- 282407  
ADOPTED ON JUL 27 1993

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is hereby authorized to file documents with the California Department of Commerce to expand the San Ysidro/Otay Mesa Enterprise Zone in accordance with regulations promulgated by the Department of Commerce pursuant to state law (Assembly Bill 251 of 1989).


2. That the City Manager is hereby authorized to take actions necessary to expand the San Ysidro/Otay Mesa Enterprise Zone to include the Otay Corporate Center North, a 178.7 acre site in the Industrial Subdistrict of the Otay Mesa Development District, as described in Attachment A hereto, which is by this reference incorporated herein.

3. That the Council of The City of San Diego hereby finds the San Ysidro/Otay Mesa Enterprise Zone, as expanded, to be an area with high unemployment and limited employment opportunities for area residents, and that designation as an enterprise zone is necessary to the creation of jobs by private enterprise.

4. That the City Manger is hereby authorized to expedite the necessary city permit processing and building permit issuance for commercial and industrial projects within the San Ysidro/Otay

Mesa Enterprise Zone, as expanded, when such expansion is approved by the California Department of Commerce.

EXPANSION OF THE SAN YSIDRO/OTAY MESA ENTERPRISE ZONE  
BOUNDARY DESCRIPTION OF  
OTAY CORPORATE CENTER NORTH

BEGINNING AT THE INTERSECTION OF OTAY MESA ROAD AND THE LINE REPRESENTING THE MOST WESTERN LIMIT OF THE OTAY MESA DEVELOPMENT DISTRICT; THENCE WESTERLY ALONG SAID OTAY MESA ROAD APPROXIMATELY 2,200 FEET; THENCE NORTH 0° EAST APPROXIMATELY 420 FEET; THENCE NORTH 31° WEST APPROXIMATELY 385 FEET; THENCE SOUTH 72° WEST APPROXIMATELY 300 FEET TO A POINT ON THE WESTERLY LINE OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 29, TOWNSHIP 18 SOUTH, RANGE 1 WEST, SAN BERNARDINO BASE AND MERIDIAN; THENCE NORTHERLY ALONG SAID LINE TO THE NORTHWEST CORNER OF SAID SOUTHEAST QUARTER OF SAID SOUTHWEST QUARTER; THENCE CONTINUING ALONG THE WESTERLY LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER AND OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 29 TO THE NORTHWEST CORNER OF THE SOUTH HALF OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 29; THENCE EASTERLY ALONG THE NORTHERLY LINE OF SAID SOUTH HALF TO THE NORTHEAST CORNER OF SAID SOUTH HALF; THENCE SOUTHERLY ALONG THE WESTERLY LINE OF SAID SOUTH HALF TO THE SOUTHEAST CORNER OF SAID SOUTH HALF; THENCE EASTERLY ALONG THE SOUTHERLY LINE OF THE NORTHWEST QUARTER OF SAID SECTION 29 TO A POINT IN THE SAID LINE REPRESENTING THE MOST WESTERN LIMIT OF THE OTAY MESA DEVELOPMENT DISTRICT; THENCE SOUTHERLY ALONG SAID LINE TO THE POINT OF BEGINNING.
