

RESOLUTION NUMBER R-282413

ADOPTED ON JULY 27, 1993

RESOLUTION CONSIDERING THE PROTESTS,
APPROVING THE ANNEXATION, APPROVING MODIFIED
MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING
THE PROPOSED MAINTENANCE, IN THE MATTER OF
THE SCRIPPS-MIRAMAR RANCH LANDSCAPE
MAINTENANCE DISTRICT.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "Scripps-Miramar Ranch Landscape Maintenance District," under Resolution of Intention No. R-281940, adopted on May 17, 1993, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests of the property owners with respect to the proposed occupied annexations to the existing district are hereby accepted and concurred in by the Council. These areas are hereby deleted from the Scripps-Miramar Ranch Landscape Maintenance District. The annexation of Lot 33 to the district is hereby approved. All other protests, if any, are overruled.

2. With the exception of the areas deleted from the proposed annexation, the assessments described in Document No. RR-281940, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.


3. The annexation of territory and the modified assessment district map for the "Scripps-Miramar Ranch Landscape Maintenance District," described in Document No. ^{m-}299-1 are hereby approved.

4. The maintenance described in said Resolution of Intention is hereby ordered performed.

5. The assessment district is approved with the per parcel assessments proposed in the report of the City Engineer. It is acknowledged that this will involve a reduction in the district's reserve funds. The proposed annexations will be reconsidered at the duly noticed hearing to be conducted next year.
