RESOLUTION NUMBER R- 282419

ADOPTED ON JUL 27 1993

WHEREAS, on August 3, 1992, the Council of The City of San Diego directed the formation of the MBE/WBE Program Review Task Force to make recommendations to improve the MBE/WBE Program; and

WHEREAS, the MBE/WBE Program Review Task Force, after receiving public input and studying the program as it is currently structured, has made a number of specific recommendations to promote an MBE/WBE Program that is both effective in meeting the stated goals of the program and efficient in function; and

WHEREAS, this Council on March 22, 1993, through Resolution No. R-281662, accepted the recommendations of the MBE/WBE Program Review Task Force and directed the MBE/WBE Program staff to respond to the Review Task Force recommendations; and

WHEREAS, the EOCP staff in conjunction with other City departments have reviewed the recommendations submitted by the Task Force and responded to concerns raised by those recommendations where necessary; and

WHEREAS, the EOCP staff has agreed to implement as soon as possible certain Task Force recommendations that are fiscally possible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the MBE/WBE Program Review Task Force recommendations on the MBE/WBE Program, and the staff response to said recommendations as set forth in the attached Report to the Honorable Mayor and

City Council on said subject, be and the same is hereby accepted.

BE IT FURTHER RESOLVED, that the City Manager is directed to immediately implement those recommendations which can be implemented within the current budget.
