ADOPTED ON Aug. 0, 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of HOLCHEM, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing LIQUID CAUSTIC SODA as may be required for a period of one (1) year beginning September 1, 1993 through August 31, 1994, at a cost of \$136.80 per ton for a total estimated cost of \$325,994.40; with terms of net 30 days, plus applicable sales tax; with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 15%.

BE IT FURTHER RESOLVED, that in the event the contract vendor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to successive low bidders, if necessary, or to obtain material on the open market until the contract can be rebid.
