

RESOLUTION NUMBER R-282435

ADOPTED ON AUG 02 1993

WHEREAS, the Legislature enacted AB 2766 (Health and Safety sections 44220-44237) authorizing the Air Pollution Control Board to establish a vehicle registration fee surcharge to implement motor vehicle related emission reduction programs; and

WHEREAS, the San Diego Air Pollution Control District (APCD) has requested proposals for projects to be funded by said vehicle registration fee surcharges; and

WHEREAS, The City of San Diego has applied to APCD for funding to administer the employer trip reduction program; and

WHEREAS, SANDAG has recommended that vehicle registration fee revenues be used for Employer Trip Reduction programs; and

WHEREAS, APCD staff is recommending a delay in making these funds available for Employer Trip Reduction; and

WHEREAS, the State Air Resources Board (ARB) has designated Employer Trip Reduction as a key element of the region's Air Quality Strategy; and


WHEREAS, The City of San Diego has operated an employer trip reduction program since July 1990 with proven success toward this region's air quality and congestion reduction objectives; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Air Pollution Control Board be requested to favorably

consider the City's request for current and ongoing funding to administer the City's employer trip reduction program efforts.
